This agreement made the _____ day of _____, _____ between Lea Ann Hansen and Glamorgan Manor, Inc, hereafter referred to as the STALLION OWNER and _____, hereafter referred to as MARE OWNER/AGENT. In consideration of the mutual promises contained herein, the parties agree as follows:

1. The MARE OWNER/AGENT shall pay the stud fee to the American Trakehner Association as stipulated in the rules of their stallion service auction. The contract is valid for two breeding seasons only (2011 and 2012).
2. The MARE OWNER/AGENT shall return a copy of the mare's papers and photo with this contract to the STALLION OWNER. This mare is subject to acceptance by the STALLION OWNER. If the photo is to be returned, a self-addressed, stamped envelope shall be provided by the MARE OWNER/AGENT.
3. If a licensed veterinarian determines that the mare is unsuitable for breeding, the MARE OWNER/AGENT may substitute a new mare, subject to acceptance by STALLION OWNER. This mare shall be bred under the same terms and conditions as the original mare. No refunds will be given if a substitute mare cannot be found.
4. The MARE OWNER/AGENT shall have the choice of fresh cooled semen or on-premise fresh semen (artificially inseminated) with associated fees and requirements as listed below. All leftover semen will be destroyed by a licensed veterinarian who will document destruction in his or her records such that it may be provided to STALLION OWNER upon request. MARE OWNER/AGENT should initial next to the type of semen desired:

- _____ Fresh cooled semen
 - Container deposit = \$250 (will be refunded if container is returned within 5 business days of receipt)
 - Collection fee = \$150 per shipment
 - Shipping fee = billed at cost
 - Semen is collected Monday through Friday (March through September) except during competitions. Saturday collection is available if MARE OWNER/AGENT arranges another courier method. MARE OWNER/AGENT shall notify STALLION OWNER at the beginning of the mare's heat cycle so that availability of the shipping container can be assured. MARE OWNER/AGENT must have a licensed veterinarian examine the mare to determine the phase of ovulation and recommend the proper time to request shipment of semen. Written verification of this exam may be requested by the STALLION OWNER. Semen must be ordered before 7:30 pm Eastern Time on the day before collection. The primary contact number is 804-393-0464. The backup number is 804-393-0498.

- _____ On-premise breeding by artificial insemination
 - Subject to stall space availability

- Mare-only daily board = \$22
 - Mare-and-foal daily board = \$26
 - Collection fee = \$100 per insemination
 - Required veterinary services will be arranged through Rappahannock Equine Clinic and billed separately by them
5. STALLION OWNER agrees that if all fees have been paid and the mare subsequently as a result of this breeding does not have a live foal that can stand and nurse unassisted, the contract can be carried forward to the 2013 breeding season. Once a live foal has been delivered that can stand and nurse unassisted, this contract is deemed fulfilled. The live foal guarantee is valid only if the MARE OWNER/AGENT has properly maintained the health of the mare and verifies the mare's pregnancy loss, stillbirth, or newborn foal death by notifying the STALLION OWNER and providing a signed and dated veterinary certificate verifying the loss within 14 days of its occurrence.
 6. All fees described in this contract will be billed to the credit card authorized by MARE OWNER/AGENT. If the credit card charge is denied, a bill will be generated with an additional \$10 service fee. All bills will be due within 10 days of the billing date and will be paid by cashier's check or money order. Balances outstanding after the due date are subject to finance charges at the rate of 1.5% per month. In addition, if the MARE OWNER/AGENT fails to pay any amount due for more than 30 days after the billing date, STALLION OWNER is not obliged to perform further under this contract until all past-due amounts have been paid.
 7. If the stallion Schiffon is not available for breeding or re-breeding due to reasons such as illness, infertility or death, STALLION OWNER is not liable for refund, re-breeding or any other claim.
 8. The MARE OWNER/AGENT shall assume all responsibilities for the condition of the mare and shall bear all risk of loss or damage to the mare whatsoever by death, disease, injury, infection or otherwise, and by any cause whatsoever, including inappropriate, untimely, or negligent insemination or failure of insemination. The MARE OWNER/AGENT therefore holds harmless Glamorgan Manor Inc, its owners, employees, agents and officers from any liability for any and all damages associated therewith. The MARE OWNER/AGENT hereby agrees to pay all expenses and attorney's fees incurred by Glamorgan Manor, Inc. in defending any claims for which MARE OWNER/AGENT has agreed to release, discharge, indemnify and hold harmless Glamorgan Manor, Inc. its owners, employees, agents and officers.
 9. The MARE OWNER/AGENT agrees to pay all collection costs, including attorney fees, court costs, necessary travel expenses, postage or express mail fees and the like reasonably incurred by STALLION OWNER or a collection agency in their attempts to collect any amounts due hereunder or enforce the term hereof. This clause shall allow collection of said funds whether or not suit is filed.
 10. Any matter of a legal nature shall be settled in the courts of Caroline County, Virginia
